Consent Calendar:

Kent Wrede moved, Hannes Becker seconded to approve April 20<sup>th</sup> minutes as drafted. Vote was unanimous. Hannes Becker moved, Mike McGrath seconded to accept the financial reports. Vote was unanimous.

Items for Report, Discussion and Possible Actions:

5. a The price list was discussed. Mike McGrath moved and Kent Wrede seconded that the District increase the price for an adult burial plot to \$1,350, and increase the endowment charge to \$250. Both increases to be effective on June 1, 2020. The vote to increase was unanimous.

5. c Correction to Trustees' book tabled until next meeting.

5. d Trustees discussed that a bond had come due. \$61,000.00 will be reinvested with the remainder for Capital improvements.

5. e Catherine Culver will look at having an overlay done on the oval encircling the Sunrise Center Section. Tony Eusted or Hannes Becker will obtain quotes for a carport structure over the dirt & material.

Item 5. B, C & D was tabled and placed on June 15<sup>th</sup> meeting for discussions. The Trustees discussed them all (except c- Kent had not gotten to yet), but no action was taken.

Trustees Reports:

Darla McGrath suggested that the Trustees need to support Tony Eusted with directions.

Kent Wrede suggested that the trustees meet at Sunrise Cemetery to see possible Niche location.

No other trustee reports were made.

Grounds keeper reports:

Since March 16<sup>th</sup> meeting we had 10 Burials. We had 8 Full casket burial and 2 cremation burials, giving us a total of 23 burials since the first of the year (12 Full casket burials and 11 cremation burials. Also call Hal at Christy Vault Company regarding a new Niche. Hal's working on with pricing and layout.
